EXECUTIVE ORDER NO. 010

AN ORDER DECLARING THE SUSPENSION OF CLASSES IN PRE-SCHOOL, ELEMENTARY AND HIGH SCHOOL LEVELS, BOTH PRIVATE AND PUBLIC, WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF ILAGAN ON JULY 17, 2019 DUE TO TROPICAL STORM FALCON (INTERNATIONAL NAME: DANAS)

WHEREAS, it is a declared policy of the State to uphold the people's right to life, health, safety and property, and to promote the general welfare especially during disaster and calamities;

WHEREAS, the local government unit is mandated to institute measures and mechanisms on disaster risk reduction and management and provide pro-active measures to secure the life, property and safety of its constituents;

WHEREAS, in a bulletin issued 5:00 AM of July 17, 2019, Wednesday, the Philippine Atmospheric, Geophysical, and Astronomical Services Administration (PAGASA) said Falcon is already over the coastal waters of Aparri, Cagayan, en route to the direction of Babuyan, and continues to have a maximum winds of 65 km/h and gustiness of up to 80 km/h, placing the Province of Isabela under Signal No.1;

WHEREAS, based on the Pre-disaster Risk Assessment from the City Disaster Risk Reduction and Management Council, the typhoon may strengthen the Southwest Monsoon bringing more rains that may cause the swelling of rivers, thus anticipating the occurrence of flooding to low-lying areas and flood-prone barangays;

WHEREAS, preemptive measures have been recommended by the CDRRMC to prevent untoward incidents and ensure the safety of the general public from unprecedented dangers to their lives;

WHEREAS, as precautionary measures and in anticipation of any developments that may arise due to the said weather disturbance, it is deemed expedient to implement a localized cancellation or suspension of classes in the City of Ilagan, and to provide the people enough time to prepare and keep them safe at all times;


NOW, THEREFORE, I, JOSEMARIE L. DIAZ, *City Mayor* of the City of Ilagan, Isabela, by virtue of the powers vested in me by law, do hereby order:

Section 1. All Classes in pre-school, elementary and high school levels in the City of Ilagan, Isabela, both public and private, are hereby suspended on July 17, 2019.

Section 2. All government agencies directly involved in disaster risk reduction management and provision of medical and emergency services shall maintain the operation of their offices to ensure the delivery of these services.

Section 3. This Order shall take effect immediately.
