**AN ORDER REORGANIZING THE COMPOSITION OF THE LOCAL SCHOOL BOARD (LSB) IN THE CITY OF ILAGAN, ISABELA.**

**WHEREAS**, Section 1 of Article XIV of the Philippine Constitution mandates the State to uphold the protection and promotion of the rights of all citizens to quality education at all levels and take appropriate steps to make such education accessible to all;

**WHEREAS**, Section 98 of the Local Government Code of 1991 provides for the mandatory creation of Local School Board in every Local Government Unit;

**WHEREAS**, education stands as one of the core priorities of the City Government, recognizing its importance as a great social equalizer towards a better quality of life and as a building bloc of developing a culture of excellence;

**WHEREAS**, the Local School Board, one of the local special bodies of the LGU shall assist the Local Chief Executive in the planning, preparation, enforcement and implementation of various programs of the LGU in the education sector;

**WHEREAS**, the election of new officials in this local government unit necessitates the reorganization of the Local School Board in the City of Ilagan;

**WHEREAS**, based on the above premises, the City Government would like to ensure the seamless transition to the new administration including the continuity of the functions and programs of the Local School Board;

**NOW, THEREFORE, I, JOSEMARIE L. DIAZ, City Mayor** of Ilagan, Isabela, by virtue of the powers vested in me by the laws of the Republic of the Philippines, do hereby order the reorganization of the Local School Board in the City of Ilagan, Isabela, with the following composition, to wit:

**SECTION 1.** Composition. The Local School Board shall be composed of the following:

**Section 2. Functions.** The City Local School Board shall have the following functions:

- a. Determine the annual supplemental budgetary needs for the operation and maintenance of public schools within the city;
- b. Serve as advisory committee to the city government on educational matters such as, but not limited to, the necessity for and the uses of local appropriations for educational purposes;
- c. Recommend changes in the names of public schools within the territorial jurisdiction of the City of Ilagan for enactment by the Sangguniang Panlungsod.

**Section 3. Consultation.** The City Schools Division Office shall consult the Local School Board on the appointment of division superintendents, district supervisor, school principals and other school officials.

**Section 4. Prohibition from Delegation.** The performance of the duties and responsibilities of the officials of the LSB shall not be delegated.

**Section 5. Meetings and Quorums.**

- a. The LBS shall meet at least once a month or as often as may be necessary.
- b. The Chairman of the LSB shall call a meeting pursuant to the above provisions. A majority of all its members shall constitute a quorum. The Chairman shall preside over the meeting.

**Section 6. Effectively.** This Order shall take effect immediately.
